

## IMPORTANT INFORMATION

Effective **February 1, 2000**, the following changes have been adopted by the Board of Directors.

A **\$1.00 per animal** fine will be assessed for all entries postmarked after the date specified in the show catalog,

**(Rule #4 of Show Rules)**

**Ear tag changes** made after the date and time specified in the show catalog, **(Rule #7 of Show Rules)**, will be assessed a **\$1.00 per change** charge.

New **Day of Show Entry** fee of **\$5.00 per animal** is now available for exhibitors not able to comply with the deadline as stated, **(Postmark Rule #4 of Show Rules)**. This **Privilege** may not be extended if the show has already filled to capacity. **Please contact the show secretary to obtain approval before arriving at the show.** Exhibitor must submit their request and receive acceptance to enter animals 30 minutes prior to the start of the show.



GSCBA Shows are now Cal State Sanctioned. If you are a member of the California State Rabbit & Cavy Breeders Association, be sure to include your membership number on your entry form.

Only members who list their membership numbers will get sweepstakes points for CSR&CBA Sweepstakes winners are announced at the California State Convention

## SHOW RULES

1. This is a **ARBA & ACBA Sanctioned OPEN SHOW**. The show will be governed by the latest revised rules of ARBA and ACBA. With signing and submitting of the entry form this implies acceptance of these rules.
2. This is a one day carrying cage show to be held at the Stanislaus County Fairgrounds, Turlock, CA. The show will be held on February 26, 2005.
3. **Entry fees for this show will be \$3.50 per animal, per show. Fee for entry of the same animal into both shows is \$6.00.**
4. Cavy entries **MUST** be postmarked no later than Wednesday, February 16, 2005. Please mail entries to the show secretary:

5. Check or Money Order must accompany the entry.  
**Make check or Money Order payable to GSCBA**
6. Your phone number must be on the entry form.  
Calls made for incomplete or illegible entry information will be made collect.
7. Phone changes will be accepted until **8:00PM Feb. 23** by calling the show Secretary. **After 8:00PM Feb. 23 any changes of Breed, Sex, Variety or class will not be made. Ear tag changes will be made at the show, before judging begins, with a cost of \$1.00 per change.**
8. **Youth Show to begin at 8:30 AM. Open Show to begin at 8:30 AM also.**
9. No Certified Mail will be accepted.
10. All judging comment cards, specials, and/or trophies must be picked up at the show. They will not be mailed or delivered. Legs will be mailed with the exhibitors report.
11. All exhibitors are responsible for their animals to and from the judging tables. GSCBA will not attempt to provide carriers.
12. All Animals are entered at the owners risk. Show personnel and the judges are in no way responsible for death, injury or loss of any animal, but all possible care will be taken to safeguard the animals.
13. Parents are responsible for the conduct of their children. Parents will be required to repair any all damage caused by their children. If damage is of a nature that cannot be repaired, the parent will be responsible to pay for the repair costs incurred. The GSCBA may refuse entry of that youth at other GSCBA shows.
14. No person, other than show officials, judges, and clerks shall be allowed behind the judging tables during judging.
15. All cavies must be permanently earmarked in the left ear, and ear markings must correspond with entry form.
16. No selling of items including Animals and Used items is allowed without entering the show and / or donating to the raffle. NO booth space available for Retail Vendors and / or Animal Rescue Area.
17. The Show Chairman reserves the right to assign, reassign, add or substitute judges as necessary.
18. Any and all questions not covered by these or ARBA rules, shall be decided by the Show Committee and Superintendent. All parties shall abide by these decisions.
